Vice-Chancellor booked for 'illegal' religious conversion

A case has been registered against 10 named people, including a Vice-Chancellor, and 50 others unidentified people for alleged illegal religious conversion of a man, police said on Saturday. Police filed the case responding to a complaint filed by Sarvendra Vikram Singh, a resident of Sultanpur, who said he had come to Fatehpur for some work on Jan 25, 2021, Circle officer (City) Veer Singh said. He later met Ramchandra in Sujrahi village, who told him Sam Higginbottom University of Agriculture, Technology and Sciences (SHU-ATS), Prayagraj, was giving money on adopting Christianity, and it will also bear the running expenses for his family. Ramchandra took Sarvendra to the Indian Press Church in Deviganj, where he met a priest, who told him about the money offer and also after this conversion. After this, Sarvendra went with the priest to Naini in Prayagraj where underwent the conversion, the CO said. SHUATS V-C RB Lal is among the 10 people named in the FIR, he said. "Sarvendra had adopted Christianity from Hinduism. Subsequently, he again converted back to Hinduism, and then lodged a police complaint, after realising his mistake," the CO said.

Mauni Amavasya: 2 crore people take dip in Ganga

A large number of devotees reached the 'mela' area at the Sangam on Friday for Mauni Amavasya and Shani Amavasya. From midnight on Friday to noon on Saturday, two crore devotees took a dip in the Ganga and the Sangam, Divisional Commissioner (Prayagraj) Vijay Vishwas Pant said. More than 5,000 personnel have been deployed to ensure security at the fair. Senior Superintendent of Police (Magh Mela) Rajeev Narayan Mishra said. Arrangements have also been made for river ambu-



lances and floating police posts. The crowd is being monitored through CCTV, body and drone cameras, he added. Several prominent seers came to the fair on Mauni Amavasya while Deputy Chief Minister Keshav Prasad Maurya also took a dip in the Sangam. The next bath will take place on Basant Panchami on Jan 26 and Maghi Purnima on Feb 5.
